Psychological Evaluation

- Assessment collecting relevant information in an effort to reach a conclusion
 - To understand the individual (idiographic)
 - To predict behavior
 - To plan for treatment
 - To evaluate treatment outcome
 - To evaluate service eligibility
- Clinical diagnosis the process of determining whether the individual meets the criteria for a psychological disorder

Procedures


Assessment interviews

Three procedures commonly used in psychological assessments include:

Clinical observation of behavior

Psychological tests

Benefit of Norm-referenced Tests

Intelligence tests

Four general categories of psychological tests for use in clinical practice are Personality tests

Adaptive Behavior Scales

Behavior Assessment

Psychological, or Neuropsychological?

Focused on medicallybased cognitive impairment

Measures cognitive, perceptual, and motor performance

Provides clues to extent and location of brain damage

Neuropsychological examination

The Referral Question

- Many Psychological Evaluations will use some neuropsychological assessment tools.
- Begin with a Psychological Evaluation.
- In the referral, clearly describe the question(s) you want answered.
- If the question is beyond the scope of our practices, we will recommend that you refer.

Diagnosis

- Assigning a person to one category rather than another.
- Though a Psychological Evaluation results in a diagnosis, generally, the purpose of a Physician-referred Psychological Evaluation will be to assist with clarification of a diagnosis.
- FASD diagnosis follows a specific process in our region

Diagnosis and Recommendations for Treatment Planning

- Diagnosis consists of two intertwined tasks: Classifying the behavior pattern within an accepted diagnostic system, and *determining the nature and source of a person's abnormal behavior* to assist with treatment.
- Diagnosis should be more than mere classification, more than the assignment of a label.

Common Reasons to Refer

- Suspected learning disability
- Suspected intellectual disability
- Concern for fetal alcohol spectrum disorder
- Complex behavioral or psychiatric problems
- Memory complaints (age-related or otherwise)
- Patient would benefit from self-knowledge
- There is a need to establish service eligibility
- Others?

Referral Process

- Discuss your recommendation with your patient
- Discuss their options for psychological evaluation
- Document referral for psychological testing in your note
- Medical case managers have been assisting with forwarding these referrals
- Your feedback: has this been working?

Practical Details

- Typically, testing not conducted on children under five
- Both psychologists bill independently
- Both psychologists take Medicaid and work with clinics to arrange Medicaid travel for village patients
- Also work with private insurance plans
